- 1987** Founded under the name Technology Services International.
- 1989** Legally incorporated and re-named Targray Technology International Inc. (TTI). Wins its first recorded sale for CD Mastering Services.
- 1990** Optical Media sales now include glass mastering services and CD jewel box sales.
- 1995** Begins production of Targets followed by a complete line of Sputtering Targets for all optical media formats, in the most common materials, for virtually all metalizers.
- 1997** Enters into an agreement with Dow Chemical for polycarbonate sales. Dow Chemical becomes a key partner in Targray's Optical Media growth.
- 1998** Opens first office in Europe in Dordrecht, Netherlands. Re-locates to larger facilities to accommodate increased inventories and growing team.
- 1999** Opens first sales offices in Asia and the U.S. in Hong Kong, and Laguna Niguel, California.
- 2000** Approximately 50% of all discs manufactured worldwide are now sputtered with a Targray target. Opens sales office in Taipei, Taiwan.
- 2001** Opens sales office in Panenske Brezany, Czech Republic.
- 2004** Enters Recycling industry. Wins prestigious Chamber of Commerce Export Award and opens sales office in New Delhi, India.
- 2005** Launches Targray Solar Division. Opens sales office in Essex, England.
